**Eligibility:** Open to any brother or sisters (ages 9-21) of a full paying member of the NEPGA Jr Tour.

**Registration:** Families must **first** register their full paying member of the NEPGA Jr Tour at [www.nepgajuniortour.com](http://www.nepgajuniortour.com), and then submit the completed application (FAX OR MAIL) for **each** additional sibling (see below for the application). Please allow 2-days upon receipt of the application for membership to be processed.

Once the sibling membership is processed, you will be emailed a username and password from the BlueGolf Tournament Software. Keep this information in a safe place as this allows one to log in to sign up for tournaments. \*\*note to remember—the user id and password will be sent in all caps(uppercase) you will need to use all lower case to log in.

### CODE OF CONDUCT PLEDGE AND VIOLATIONS

I, \_\_\_\_\_, agree to observe the USGA Rules of Golf. I agree to practice proper Golf Etiquette at all times. I agree to observe and abide by any and all rules and conditions of the competition as mandated by the NEPGA, including but not limited to all the rules in the 2011 Players Handbook. I understand that my membership may be suspended or cancelled for willful disregard of the Rules of Golf, Golf Etiquette, or dishonest, unsportsmanlike or unbecoming conduct. I understand and agree that all decisions of the NEPGA are final. I understand that in the event of disqualification, suspension or termination of membership, any and all fees and membership dues that have been paid are non-refundable.

Abusive or foul language, club throwing, cheating, disrespectful behavior toward volunteers, officials, host club members or fellow participants, abuse of the golf course, drug or alcohol abuse, smoking or chewing tobacco products, failure to adhere to and abide by the dress codes of either the NEPGA or the host facility, or any other conduct deemed inappropriate by the New England may result in the termination of membership and or suspension of playing privileges. If a NEPGA Junior Program member violates the Code of Conduct, any or all of the following will occur:

1. Verbal warning to player and parents.
2. Immediate disqualification of the member from the event where violation occurs, including, if deemed necessary by the NEPGA Official in Charge, immediate removal of the player and/or parents/guardians from the premises.
3. Suspension from one or all-future events including termination in full of Membership.
